RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

You further state and acknowledge that you have fully informed yourself of the contents of this release by reading and reviewing it before you have signed it, and that you had the opportunity to ask questions about anything you did not understand.
